Dear Competitor,

Thank for your entry & Welcome to the Circuit of Munster Rally 2015.

Deebert House Hotel, Kilmallock is the HQ for the rally. The official notice board will be in rally HQ

08.15 Saturday 30th May Rally Office will open @ HQ for Recce Sign-On. **{All crews must sign on for recce}** Please bring your Competition Licence, IRDS & entry fee as we intend to do all the paper work at this time (Documentation scrutiny).

Competitors are allowed a Maximum of 3 Recce runs on Stages from 08:30 to 16:00. Please have respect for the residents while doing your Recce.

On arrival in Kilmallock ALL SERVICE VECHILES AND TRAILERS must unload/ park in service area {Golden Vale Mart Kilmallock}.

Scrutiny will take place in the industrial estate on the R518 (Bruree Road, Kilmallock) from 14:00 to 19:30 follow road book from trailer park and obey Marshal's instructions on arrival there. **NO** service vehicles or trailers are allowed in the scrutiny area.

Mechanical scrutiny is by request only on Sunday morning, with prior arrangement with the Clerk of the Course and the Chief Scrutineer.

Overnight Security will be provided in Parc Ferme.

All crews must have a ground sheets

Competitor's Safety Briefing will take place in Rally HQ on Sunday morning at 08:30 (Compulsory for ALL Crews).

FCD out of Parc Ferme @ 09:40 & FCD out of Service before ss1 @ 09:56.

Final Control will be at Parc Ferme on Sunday evening, FCD @ 16.35.

No trailers or service vehicles allowed into the hotel grounds.

Competing cars will be permitted to carry advertising as per Appendix 2 article 14.1 windscreen and windows shall bear no advertising, with the exception of a maximum *10cm high strip on the upper part of the windscreen* and provided that this does not interfere with the visibility of the driver, an *8cm high strip on the rear window*.

GCR 187.2. Cars entered by residents of any part of the united kingdom who hold MSA competitors licence may carry advertising in accordance with MSA rules when competing in the events in Ireland held under MI permit.
